AFFILIATE AGREEMENT

This agreement describes the terms and conditions for participation in the (NET Institute's) Affiliate Program also referred to as "NAP". The terms "Affiliate," "you," and "your" are referring to you, the applicant. "We" and "our" refers to NAP or NET Institute. We are independent parties and this agreement will not form any partnership.

AGREEMENT DURATION

This agreement will begin upon our acceptance of your affiliate application and will end when terminated by either party. Termination may happen at any time, with or without cause, by giving the other party written notice of termination.

MODIFICATION

By posting a Change Notice or a new agreement on this site, we may modify any of the terms and conditions within this Agreement at any time and at our sole discretion. These modifications may include, but not limited to changes in the scope of available referral fees, fee schedules, payment procedures and Program rules. If any of the modifications are UNACCEPTABLE TO YOU, your only recourse is to terminate this Agreement. If you CONTINUE PARTICIPATION IN THE PROGRAM following the posting of a Change Notice or new agreement, it will be considered as your acceptance of the change.

COMMISSION FEES

You will receive (20%) of the revenue as a commission from orders placed through your Affiliate Link on your website which is connected to www.netinstitute.org. For a sale to generate a commission to an Affiliate, the customer must purchase a course or program by clicking on the affiliate link assigned to Affiliate. We are not responsible for and will not pay commission on orders purchased directly from the NET Institute website. Affiliate commissions will only be paid on sales which are made through qualified Affiliates. Commissions will be paid once per quarter, no later than the 15th of the month following the previous quarter ending period. Yearly quarters are broken down as follows: (Jan. 1 – Mar. 31- payment due April 15th; | Apr. 1st – Jun 30th - payment due July 15th | Jul. 1st – Sep. 30th - payment due October 15th | Oct. 1st – Dec. 31st payment due Jan. 15th).

Any refunds to customer will be adjusted or deducted from the following commission payment.

ORDER PROCESSING
